Dr. Illich presented the results of the institutional research and external study on demand for Lincoln Campus Student Housing and how the research was conducted, showing demand for student housing. He also discussed design considerations.

Additionally, Dr. Illich, Scott Keene of Piper Sandler, and Colleen Duncan of Gilmore Bell, presented information on past and future financing, the revenue bond timeline for this project, and the bond resolution.
